Persons or organizations approved for use of the facilities shall and do hereby assume the risk of all damage, injuries, claims, actions, causes of actions, losses, costs and expenses, including attorneys' fees, and shall indemnify and hold harmless and do hereby release Longevity, its officers, agents, and employees, from and against any and all liability, damage, injuries, claims, actions, causes of actions, losses, costs and expenses, including attorneys' fees, which may accrue to or be sustained or incurred by Longevity, its officers, agents or employees, on account of any claim, suit or action, demand or any action made or brought against Longevity, its officers, agents or employees, arising from any matter in connection with the above event. Event must be covered by insurance: \$1,000,000 per accident, \$100,000 property damage. Longevity must be named additional insured and be given a copy of the certificate of insurance.

Any and all damage to grounds and/or facilities, including losses from theft, that may result from Applicant's use of the facilities must be fully and completely restored and/or replaced within three(3)days after the end of the event.

Applicant agrees and acknowledges that it or its representative has inspected and examined the above-described facilities and has ascertained for itself all physical and other conditions in relation thereto, and assumes all risk involved in using the above-described facilities for the event.

Where advance scheduling in excess of thirty (30) days in requested, Applicant acknowledges Longevity's right to change the requested room or space assignments in the event such assignment shall prevent Longevity from future leasing of the space or spaces for long term commercial purposes.

The undersigned person signing for the Applicant represents that he is fully authorized and empowered to act for and bind the Applicant.

This agreement shall be binding upon and shall inure to the benefit of the parties to this agreement and their respective successors and assigns, or heirs and personal representatives, if applicable.
